## NOTICE OF INTENT TO SUSPEND LICENSE

Chuedang Vue Rice Palace Asian Buffet 1626 White Bear Avenue North Saint Paul, MN 55106

All licenses held by TSWJLAUG, Inc. d/b/a Rice Palace Asian Buffet for the premises located at 1626 White Bear Avenue North in Saint Paul License ID # 20100000030

Dear Chuedang Vue:

The Department of Safety and Inspections (DSI) has recommended suspension of all licenses held by TSWJLAUG, Inc. d/b/a Rice Palace Asian Buffet for the premises located at 1626 White Bear Avenue North in Saint Paul. The basis for the recommendation is as follows:

On November 26, 2012, you were sent a <u>THIRD REQUEST</u> from the Department of Safety and Inspections (DSI) requesting you submit your State Liquor Renewal Certificate and copies of your monthly state sales and use tax statement from the previous twelve (12) months from the Department of Revenue. You were given until December 10, 2012 to submit this information. As of today's date it has not been received.

Also, according to DSI records you have not paid the \$1,153.50 in delinquent license and late fees for your Wine On Sale (Second Half) license.

In addition to the suspension of your licenses for non-payment of delinquent license fees, per Saint Paul Legislative Code §310.05 (m) (2), the licensing office will also recommend a \$500.00 matrix penalty for failure to submit the requested information in order to maintain your license.

At this time, you have three (3) options on how to proceed:

1. You can pay the delinquent license and late fees and submit the required information indicated above. If this is your choice you should send the payment and information directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday**, **January 28**, **2013**. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent license and late fees and submission of the required information will be considered to be a waiver of the hearing to which you are entitled.

- 2. If you wish to <u>admit</u> the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting the facts and requesting a public hearing no later than **Monday**, **January 28**, **2013**. The matter will then be scheduled before the City Council for a public hearing to determine whether to suspend your licenses and impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 3. If you no longer wish to do business in the City of Saint Paul, you will need to send a written statement to that effect to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday**, **January 28**, **2013**. A self-addressed envelope is enclosed for your convenience.

If you have not contacted me by Monday, January 28, 2013, I will assume that you do not contest the suspension of your licenses and imposition of the \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
