## **CORRECTION NOTICE**

**RE: 1763 THOMAS AVE**

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **June 27**, **2012** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

- 1. SCRAPPING/RECYCLING: Scrapping and/or recycling processing is **not permitted** in a residential zoning district per section 66.221 of the St Paul Legislative Code. A home occupation is permitted in a residential district provided it meets the requirements in Section 65.141 of the St Paul legislative code. This section of the code requires and states there shall be no exterior storage of equipment, supplies or commercial vehicles associated with the home occupation. Additionally, it is required that the dwelling unit be the principal residence of one of the persons conducting the home occupation. IMMEDIATELY CEASE SCRAPPING OPERATIONS.
- 2. AUTO REPAIR: Auto repair is **not permitted** in a residential zoning district. Cease auto repair business.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after

## July 10, 2012,

by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**<sup>2</sup> and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk's Office at 651-266-8688. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
