### CORRECTION NOTICE – FOSTER CARE INSPECTION

RE: 1458 ARONA ST

Dear Property Representative:

An inspection was made of your building on March 25, 2013 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately. A re-inspection will be made on April 22, 2013 at 1:00PM.

#### DEFICIENCY LIST

- ANNUAL HEATING EQUIPMENT MAINTENACE PROVIDE DOCUMENTATION SPLC 34.11 1. (6), 34.34 (3) - Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- BACK DOOR REPLACE DOUBLE CYLINDER LOCK MSFC 1003.3.1.8 Remove unapproved 2. locks from the exit doors. The door must be openable from the inside without the use of keys or special knowledge or effort. Replace the double cylinder lock on the back door.
- BASEMENT PROVIDE GROUND CONNECTION MSFC 605.1 Provide a permanently attached 3. grounding connection for the electrical service.-Ensure that the current ground wire is properly attached in an approved manner.
- BASEMENT RELOCATE REFRIGERATOR NEC 440.13 For cord-connected equipment such as 4. room air conditioners, household refrigerators and freezers, drinking water coolers, and beverage dispensers, a separable connector or an attachment plug and receptacle shall be permitted to serve as the disconnecting means. The appliance must plug directly into a permanent outlet.-Relocate the basement refrigerator so it plugs directly into a wall outlet without the aide of an extension cord or power strip.
- BASEMENT NOT TO BE USED FOR SLEEPING MSFC 1026.1 Provide and maintain an 5. approved escape window from each sleeping room or area, or discontinue use of area as a sleeping room. This work may require permit(s). Call DSI at (651) 266-8989.-The basement is not to be used for sleeping. The openable dimensions of the south window are 12 inches high by 20 inches wide. The window sill height is greater than 48 inches.

- 6. BASEMENT DRYER REMOVE DUST AND LINT MN Stat 299F.18 Immediately remove and discontinue excessive accumulation of combustible materials.-Remove dust and lint in and around the basement clothes dryer. Ensure the dryer vent is also clear of accumulated material.
- 7. BASEMENT STAIRWAY PROVIDE APPROVED GUARDRAIL SPLC 34.10 (3) 34.33(2) Provide an approved guardrail. Intermediate balustrade must not be more than 4 inches apart. Intermediate rails must be provided if the height of the platform is more than 30 inches.-Provide approved guardrails for both sides of the basement stairway.
- 8. KITCHEN HANG FIRE EXTINGUISHER MSFC 906.1, MN Stat. 299F.361-Provide a minimum 2A10BC fire extinguisher in the kitchen. It must be permanently mounted between 3 and 5 feet high in readily visible and easily accessible location.
- 9. MAIN FLOOR SLEEPING AREA PROVIDE CO2 ALARM MN State Statute 299F.50 Immediately provide and maintain an approved Carbon Monoxide Alarm in a location within ten (10) feet of each sleeping area. Installation shall be in accordance with manufacturer's instructions.-Provide an approved CO2 alarm for the main floor sleeping area.
- 10. \*SECOND FLOOR AREA NOT TO BE USED FOR SLEEPING MSFC 1026.1 Provide and maintain an approved escape window from each sleeping room or area, or discontinue use of area as a sleeping room. This work may require permit(s). Call DSI at (651) 266-8989.-Second floor area may not be used for a sleeping area. The east window openable dimensions are 17.5 inches high and 20 inches wide.
