The email is my written statement to communicate that I am **against** the proposed new sidewalk on the west side of Kent Street between Orange and Wheelock Parkway West.

I did not attend the May 1, 2013 Meeting and I am also unable to attend the meeting on May 8, 2013. Please consider this email as record of my opposition to the installation of a sidewalk on the west side of Kent Street between Orange and Wheelock Parkway West.

This specific street does not need a sidewalk. The sidewalk would nearly eliminate the small yard space we have on the east side of our house, it would mean the likely destruction of three 16 year old spruce trees we planted when we moved in, and we would bear the expense and on-going maintenance of a sidewalk that we do not want.

This is the first occasion in the 17.5 years of living on this property that I have objected to a proposed city improvement. I fully support the efforts to enhance the neighborhood and city, and willing to pay my fair share toward this end. However in this case, the sidewalk would not be an improvement to my property and the expense is unjustified.
