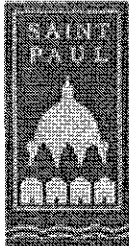

Dave Pugh has never paid his portion of the rent since he moved in. Is this something you can discuss with him

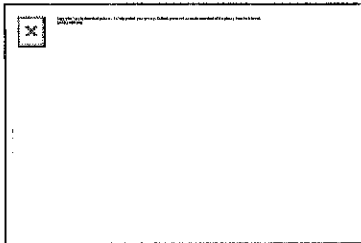
or should I file an eviction? Will he then lose his Section 8?

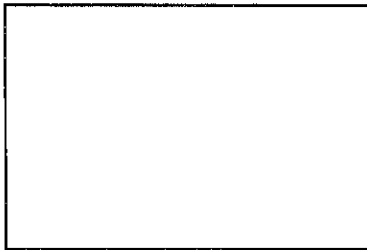

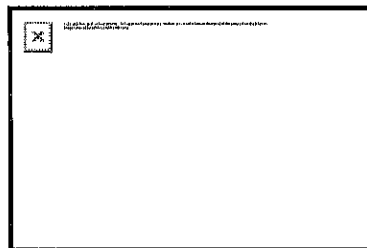
