Legislative Hearing Officer Marcia Moermond said the Council had denied the appeal on the condemnation and order to vacate the previous summer, and was now considering the appeal of the vacant building registration. She said it was clear the building should be in the registered vacant building program as it was condemned, not occupied, and didn't have a Certificate of Occupancy. At Councilmember Helgen's request she clarified that what was before the Council was the vacant building status and fee.

#### In opposition:

Terry Duggins, attorney for John Norris, Sr. and John Norris, Jr., distributed and reviewed material related to attempts to come into compliance with orders. He said they hadn't been able to find an engineer to do a code analysis, and were still waiting for clarification on what that was.

In response to a question by Council President Lantry, Mr Norris said the date of the deficiency list was May 2010. Council President Lantry asked whether the building was occupied. Mr. Duggins said there was a business there.

Mr. Duggins said they were waiting for clarification on just five items. He said they'd been there 20 years with no problems.

John Norris, Jr. said Inspector Neese was being nitpicky, and items that had been corrected continued

to appear on the deficiency list.

Mr. Duggins said going forward would have the effect of putting Mr. Norris out of business. He said they were asking for clarification and then 90 days to complete the corrections.

Councilmember Helgen moved to close the public hearing. Yeas - 6 Nays - 0 (Councilmember Harris not present for vote)

Councilmember Helgen referred to the photos in the packet showing a shed structure with no real roof, and general clutter including a variety of different materials. He said he felt it was a vacant building and the fee should be paid, and the appellant should continue to work with DSI to get the Certificate of Occupancy. Ms. Moermond clarified the engineering report requirement.

Council President Lantry noted that the photos in the file were from a year ago and from April.

Councilmember Helgen moved to adopt the recommendation of the Legislative Hearing Officer (the building is a registered vacant building, the fee must be paid, and the Certificate of Occupancy must be reinstated).
