NOTICE OF VIOLATION

RE: Second Hand Dealer – Motor Vehicle license held by Twin City Direct Auto Sale, Inc. d/b/a Twin City Direct for the premises located at 1265 Arcade Street in Saint Paul

Dear Abri:

The Department of Safety and Inspections will recommend adverse action against the Second Hand Dealer – Motor Vehicle license held by Twin City Direct Auto Sale, Inc. d/b/a Twin City Direct for the premises located at 1265 Arcade Street in Saint Paul. The basis for the recommendation is based on the following information:

**On January 29, 2013 you were sent a letter from the Department of Safety and Inspections regarding an inspection that took place on January 9, 2013. During that inspection, the Senior License Inspector found the following violations to your license conditions:**

1. There were twenty-seven (27) cars in the lot and it was not possible to exit without backing out onto the street. This is a violation of license condition #1: *There shall be no more than fourteen (14) "For Sale" cars on the lot at any one time. Eight (8) off-street parking spaces, including maneuvering area, must be maintained for customers in accordance with city requirements. "Thru-access" must be provided at all times to allow vehicles entering or exiting the site to be traveling forward.*
2. There were piles of tires and vehicle parts around the building, garbage in and around the lot and landscaping materials stored outside. This is a violation of license condition #4: *"No outside storage is permitted. No cars that are For Sale shall be parked on the street."* and license condition #7: *There shall be no exterior storage of vehicle parts, tires, oil or any other similar materials associated with the business. Trash will be stored in a covered dumpster.*
3. Vehicles were not parked according to approved site plan on file with DSI. This is a violation of license condition #6: *Customer, employee or sale vehicles shall not be parked or stored on the street or alley. All vehicles on the site must be parked as shown on the approved site plan on file with DSI dated 10/19/06. (Any changes to the site plan must be approved by the Zoning Administrator.*

**You were given until February 15, 2013 to make the necessary corrections in order to be in compliance with your license conditions.**

**On March 13, 2013, the Senior License Inspector returned for a re-inspection and found several repeat violations to your license conditions:**

- 1. There were twenty-four (24) cars in the lot. This is a violation of license condition #1: *There shall be no more than fourteen (14) "For Sale" cars on the lot at any one time. Eight (8) off-street parking spaces, including maneuvering area, must be maintained for customers in accordance with city requirements. "Thru-access" must be provided at all times to allow vehicles entering or exiting the site to be traveling forward.***
- 2. Vehicles were not parked according to approved site plan on file with DSI. This is a violation of license condition #6: *Customer, employee or sale vehicles shall not be parked or stored on the street or alley. All vehicles on the site must be parked as shown on the approved site plan on file with DSI dated 10/19/06. (Any changes to the site plan must be approved by the Zoning Administrator.***
- 3. There were pillars and other items stored outside. This is a violation of license condition license condition #7: *There shall be no exterior storage of vehicle parts, tires, oil or any other similar materials associated with the business. Trash will be stored in a covered dumpster.***

As a result, per Saint Paul Legislative Code § 310.05 (m) (2), the licensing office will recommend a \$500.00 matrix penalty and require that you bring your establishment into compliance with all your license conditions within 30 days or license will be sent to City Council for suspension.

At this time, you have two options on how to proceed:

- 1. You can pay the recommended \$500.00 matrix penalty. If this is your choice, you should make payment directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday, April 22, 2013**. A self-addressed envelope is enclosed for your convenience. Payment of the \$500.00 matrix penalty will be considered to be a waiver of the hearing to which you are entitled.**
- 2. If you wish to admit the facts but you contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter by **Monday, April 22, 2013**. The matter will then be scheduled before the City Council for a public hearing to determine whether to impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.**
- 3. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (ALJ). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than **Monday, April 22, 2013**. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.**


