#### **NARRATIVE**

I (Sergeant Charles M. Anderson/Squad 181) am assigned as an investigator in the Western District where I am responsible for investigating a wide variety of property and quality-of-life related offenses within the City of Saint Paul. In addition, I initiate numerous follow-up investigations based on arrests by patrol officers, and assist outside agencies as necessary.

I am actively involved in theft, stolen property, and shoplifting investigations. I know from training and experience that many offenders that commit theft, burglaries, and shoplifting sell stolen merchandise to storefront businesses in order to obtain money, which is oftentimes utilized to support chemical and controlled substance dependency, thereby contributing to other unlawful acts. These offenders are known as "boosters", and the storefronts that take in the stolen merchandise are known as "fencing" operations. Through my investigative experience, professional contacts, and continuing education in the area of organized retail theft, I know that common items such as laundry detergent, baby formula, baby diapers, over-the-counter medications, bedding linen sets, batteries, energy drinks, and men's razors are common items that are "boosted" from retail stores, "fenced" at storefronts, and sometimes redistributed through a wholesale "re-pack" operation. Additionally, these "boosters" often commit other crimes, such as burglaries and thefts-from-autos, in order to sell these goods to "fencing" operations. These "fencing" operations, by their support of illegal enterprise, contribute to neighborhood degradation and a perception of an acceptance for illegal activity.

I received information from non-custodial interviews, non-law enforcement corporate investigations, and a Saint Paul police burglary investigator, that the business known as "Piazza Market" located at 512 N Snelling Avenue, Saint Paul MN, tel # 651-645-7488 was involved in the illegal purchasing, storage/possession, and sale of stolen merchandise, liquid laundry detergent, cigarettes, cell phones, laptops, and other electronics. There were several store employees, and possibly an owner, involved in this illegal enterprise.

I was contacted by Target Assets Protection corporate investigator Sean CUNY. He informed me that the amount of Tide liquid laundry detergent being stolen from the sales floors of their metro area retail stores, to include stores located in Saint Paul, was impacting their losses.

I received controlled shipments of Tide liquid laundry detergent (2.95 Liters) from CUNY on 06/04/2012 (16 containers), 06/11/2012 (5 containers), and 06/12/2012 (6 containers). I received and signed an inventory for the containers of detergent, which is included with this case file. The inventories included photographs of the containers of detergent. All containers of detergent had a Target "bull's eye" logo sticker affixed to the right side of the back label. These stickers were affixed by CUNY for tracking purposes, and are not usually affixed to sales floor merchandise. I also utilized a red permanent marker to mark each container of Tide liquid laundry detergent by filling in the recycling symbol on the back label.

As part of this investigation, a confidential reliable informant (CRI) was utilized to make several sales of purported stolen Tide liquid laundry detergent to the business. On each and every occasion, I searched the CRI, and the CRI did not have any money or other types of contraband on their person. The CRI sold these items for cash to two employees on several occasions. The CRI told the employees on all occasions that the items he/she was selling to them were, in fact, stolen from Target stores. The CRI was told by the store employees to return with more Tide liquid laundry detergent. They also told the CRI to return in order to "take orders" for other types of merchandise. In exchange for the Tide liquid laundry detergent, the employees paid the CRI between \$2.00 and \$4.00 in cash, and marked the items for sale at \$9.99.

Esayas SAHLE also told the CRI that he was interested in obtaining electronics such as car stereos, cell phones, and laptop computers.

liquid laundry detergent, with a total value of \$95.92. AMANUEL SAHLE purchased seven containers of purported stolen Tide liquid laundry detergent, with a total value of \$83.93.

Amanuel SAHLE is listed in commercial and law enforcement databases, to include the Saint Paul Police Department's Record Management System, as an owner of the business known as "Piazza Market". Both AMANUEL SAHLE and ESAYAS SAHLE were described by the CRI. Their identities were verified through onsite undercover police presence, record's checks, and photo affirmation through law enforcement databases.

On 06/15/2012, I drafted a search warrant for 512 N Snelling (Piazza Market) pursuant to this investigation. AMANUEL SAHLE and ESAYAS SAHLE were also named as persons to be seized under the warrant. The search warrant applications were reviewed and signed by the Honorable OSTBY on that same date.

I supervised the execution of the search warrant for 512 N Snelling. Present at the execution of this search warrant were the following persons: Sergeant D. Day, Sergeant W. Slagle, SPPD Officers D. Boone, A. Siegfried, C. Koch, and S. Rioux. Upon entry we located Ephrem Sahle MEKONNEN, 08/20/1971, 40 yoa O/M, 5337 Oliver Avenue N, Brooklyn Center MN 55430 behind the counter. He was handcuffed until the location was secured, at which time he was un-cuffed and allowed to sit in a chair while supervised. A customer and a person renting a clothing area of the location (separate locked entrance) were identified and released.

Once the scene was safe the following non-law enforcement agent assisted: City of Saint Paul DSI Health Inspector A. Museid.

MEKONNEN stated he, along with AMANUEL SAHLE, were part-owners of Piazza Market. He stated that AMANUEL and ESAYAS were his siblings. MEKONNEN stated ESAYAS was a clerk, and not an owner.

I, along with Sergeant D. Day, located, photographed, recovered, and inventoried the following items while conducting the search:

Item #1 (3) 2.95 L Tide laundry detergent on small shelf 20 feet from main door next to second supporting pillar.

Item #2 Open pack of Newport cigarettes containing 7 cigarettes found in an open cash box below the cash register behind the counter.

Item #8 (11) cans (12.9 oz) Similac Isomil Advance powder expired 6-1-2011 found behind counter on lower shelf.

Item #9 (1) Vipertek brand handheld stungun device packaged in black box found on display shelf near n/w basement door, # X00098645T.

It should be noted that all recovered containers of Tide liquid laundry detergent were marked in the same fashion as listed for this investigation. Three of the containers had "\$9.99" written on the tops of the caps in black marker.

Sergeant Day and I packaged all items and transported them to the SPPD property room where they were turned in as evidence. I downloaded all photos to the secure Media Vault under this case number.

It should be noted that while conducting the search I located numerous items, some of them appearing to be for sale, that were suspect. I photographed some of these items. Among those items were vehicle GPS units, and several computer and televisions. I conducted item checks on serial numbers, and all items were returned clear (i.e. not reported as stolen).

Other items of interest included a large quantity of baggage, purses, and DVDs. The quality of the DVD packaging and graphics appeared poor, possibly indicating counterfeit status.

There were numerous CD stands with numerous copies of the same CD on each stand located behind the counter and marked for sale. Inside an upstairs office connected to the location, there was a workstation with multiple computers, recording devices, blank CDs and DVD discs, and computer equipment that appeared to be used for making multiple copies of digital media. I asked MEKONNEN about the operation. MEKONNEN stated that he and other employees make copies of Ethiopian music from originals, and sell the copies to customers for \$5.00 per CD.

I left a copy of the search warrant and receipt inventory form at 512 N Snelling Avenue before leaving the premises. MEKONNEN took control of the premises upon our departure.

This case will be submitted to the SPCA Office for consideration of conspiracy to commit a misdemeanor crime (receiving stolen property) against AMANUEL and ESAYAS SAHLE pursuant to SS 609.175.2(1).
