The city's costs in providing refuse service for the property will be collected from the owner(s) rather than being paid by the tax payers of the city; and that such future costs will be collected by assessment against the property as defined.

If you do not obtain weekly garbage service or file an appeal before **November 20, 2012**, the City may provide weekly garbage collection service to the above address and charge all costs against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City provides garbage collection the charges will include the costs of all trips to the address, the cost of the container, a minimum charge of \$50 per week for garbage pick-up, and other costs for bulky or unusual refuse as outlined in a fee schedule that will be delivered to the property along with the refuse container.

Dear Owner(s) and Occupants

This is to notify you that the City of St. Paul will now be providing weekly garbage service to:

1256 HARTFORD AVE

until further notice. The city Parks Department has delivered a city owned 65 gallon trash container to this property. The container is labeled with the address of the property, the day of the week that the container will be picked up and the location where the container should be placed, i.e. street or alley. The fee for this service is a minimum of \$50 per week, per container. See the attached Fee Schedule for additional cost factors.

The garbage container must be placed at the pick-up location by 7:00 AM of the day for pick-up. Refuse containers cannot be stored on the boulevard or in an alley after the collection day. They must remain in the yard until collection day and returned to the yard after collection day. The city garbage collection crew will be operating much like private garbage haulers. They will not go into a yard to retrieve the container. The owner(s) or occupants of the property are responsible for getting the container to the pick-up location on the pick-up day.

Attached to this letter is a fee schedule for added garbage collection costs. Please note that in some instances the Parks Department needs to be called in advance for pick-up of some types of refuse.

If the garbage from this property is not taken to the pick-up location on the pick-up date, but remains on the property in violation of city ordinances, a city crew will return to the property and remove the garbage at a billing rate of \$260 per hour plus costs in addition to the weekly garbage collection fee of \$50. All of these costs are subject to future raises.

To remove your property from city garbage collection the owner of the property must furnish a Code Enforcement Inspector with proof that two months of garbage collection for this property has been prepaid to a licensed refuse hauler. Proof will be in the form of a letter or other document from the licensed hauler showing that two months of garbage service has been prepaid for the address. The letter must include a telephone number for the hauler and the account number for the address. Upon receipt of the letter the Parks Department will schedule the final city garbage pick-up and the beginning of service with the private hauler. **The private hauler will not schedule the beginning of pick-up.**

If, after resuming private garbage hauling at the above address, the private hauling is discontinued, and garbage is still being generated there, the city will renew its city garbage service without further notice to the owner or the occupant. The owner is responsible for notifying the Code Enforcement office of any change in private garbage haulers. Private garbage haulers will be asked to report any discontinuation of service to your address. FEE SCHEDULE

City of St. Paul Mandatory Garbage Collection Program

1256 HARTFORD AVE

This address has been placed into the City of St. Paul Mandatory Garbage Collection Program. You may receive this fee schedule as an attachment to a letter to the owner or the occupant. In addition, this fee schedule may be delivered to the address with the garbage container.

Start-up fee:	\$50	This covers the initial administrative costs of assigning garbage service to an address and includes dropping off a container.
Weekly Service:	\$50	The City charges \$50 per week to collect garbage under this program. This is substantially higher than fees charged by private haulers. The fee covers everything that can legally be placed in the 65 gallon container.
Excess Garbage:	\$25	If garbage exceeds the limits of the 65 gallon container, additional fees of \$25 for every additional 65 gallons of garbage will be assessed.

The costs for disposal of unusual refuse is as follows: **(Note: You must call 651- 632- 2435 to arrange for pick-up of unusual items.)**

Refrigerators:	\$50
Freezers:	\$50
Stoves:	\$40
Washers:	\$40
Dryers:	\$40
Mattresses:	\$25
Couches:	\$35
Miscellaneous Furniture:	\$20 to \$40 Call first with a description
Brush:	\$10 per wheelbarrow
Demolition/Construction Debris:	\$100 per cubic yard

The following items are generally not accepted by garbage haulers and must not be placed out for collection. **These items are banned:**

Household Chemicals and Drain Oil*:	Take to the Ramsey County Household Hazardous Waste Site located at... Bay West 5 Empire Drive 651-633-3279
