#### CORRECTION NOTICE - COMPLAINT INSPECTION

Dear Property Representative:

An inspection was made of your building on August 30, 2013 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately. A re-inspection will be made on September 30, 2013 after 9:30 am.

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

#### **DEFICIENCY LIST**

- Exterior Repairs HPC Application/Review HPC Sec. 73.04(4) Review of permits. The commission shall protect the architectural character of heritage preservation sites through review and approval or denial of applications for city permits for exterior work within designated heritage preservation sites.
   355 Maria Avenue is located in the Dayton's Bluff Historic District as described in Sec. 74.76 of the Legislative Code.-Contact HPC and DSI Zoning for application and review of properties easement behind building.
- 2. West Dirt Lot Sec. 63.201. Off-street parking. Off-street parking spaces shall be provided in all districts, except B4 and B5, at the time of erection, enlargement or expansion of all buildings in accordance with the requirements of this section.
- 3. West Dirt Lot Sec. 63.303. Parking location, residential. Residential off-street parking shall consist of an off-street parking facility or parking spaces as defined in this code. Parking spaces for buildings containing three or more dwelling units shall be on the same zoning lot, park of a shared parking arrangement pursuant to section 63.206(d), in a VP vehicular parking district, or in an abutting zoning lot in the same or less restrictive zoning district. Remove vehicles, trash receptacle and stumps in ground behind building. Allow access for owners of 359 Maria Ave to complete garage repairs.

# PARKING ACCESS BEHIND 359 MARIA, SAINT PAUL,

I am the resident owner of 667 East Fifth Street, Saint Paul, MN. I have lived here since I bought the home on September 21, 1994. I share a drive way with 355/357 Maria. As it is currently laid out now, they own half of the driveway and I own half. At present there is no easement on my half of the driveway.

ISSUE: Apartments with over four units should have off-street parking. To access 359 Maria they have to drive past my house on the shared driveway between 355 Maria and 667 East 5<sup>th</sup> Street.

#### THE EASEMENT

The city says there is an easement on the 355 Maria property. They haven't said whether there is one on my property, 667 East 5<sup>th</sup> Street. But if the tenants of 359 Maria intend to use my side of the drive, I have no intention of giving an easement.

In the 20 years I have lived here, no one has ever driven through my shared drive to get to 359 Maria. When I came Neal Albrecht placed a series of posts and located the dumpster at the head of the driveway. If there was an easement it surely has been **vacated** by 20 years of non-use.

#### THE PAST OWNERS OF 359 Maria.

When I purchased my house in 1994, M and M Properties owned 359 Maria. During that time there were numerous police calls to the building. (attached report from that period) The back yard was littered with debris. (attached photos). I personally witnessed many drug purchases from the back door.

When Mr. OH purchased the property, the drug dealing continued which I have witnessed, and there has been an escalation in violence. In fall 2011 my bedroom window was shot at by the group who shortly before were firing pellet guns from the back steps of 359 Maria. I have 6 holes in my windows to show you. The windows are directly above my bed and the shots were at 10:00 or so at night when I was in bed. By the time I looked out the window they were going back into 359 Maria. The police were called and a report was made, but they didn't come until the next morning. By that time Mr. Oh said he didn't know if it was his tenants or their guests, and he was not responsible for the guests. Although there was no legal grounds for arresting the occupants of 359 Maria at that time, the event arose out of that building, and the owner is culpable for a lack of oversight.

On two further occasions January 12, 2012 and January 18, 2012 my kitchen window was shattered and my home was burglarized. A resident of 355 Maria saw two young men in my yard

within two minutes of the burglary. These were people who lived at 359 Maria. When the police talked to the witness, they were not able to enter 359.

The Owner, Mr. OH was called on each occasion and he said it was not his problem. He said he did post a notice on the door as did other landlords. That was the extent of his oversight.

#### HOW IS THE PROPERTY KEPT?

359 Maria has seldom seen the owner Mr. OH. He has asked someone who is not a professional custodian to vacuum the corridors and maintain the lawn, but he doesn't check on them to my knowledge. Often the grass is over the city height limit and the weeds abound. There has been no attempt to create a decent grassed area behind the house for the residents.

#### WHAT WILL BE THE EFFECT OF A PARKING LOT BEHIND 359 MARIA?

- 1. There will be no green space for the tenants who are Section 8 and therefore often have small children.
- 2. It will continue to degrade the residential character of the neighborhood where there is ample street parking.
- 3. Because of the remoteness it will create a fertile ground for concealed drug dealing. The police are aware this property is a hot spot for drugs. I have talked with Officers Thor Johnson, Townsend, Louis Ferraro and Captain McCray about the activity.
- 4. The drug activity will encourage people to drive all night long past my house and 355 Maria.

#### WHAT IS BEST FOR THE NEIGHBORHOOD?

This is a stressed neighborhood that hasn't changed much in the time I have lived here. There is a movement along 4<sup>th</sup> and Maria to improve houses, but between 5<sup>th</sup> and 6<sup>th</sup> there are abandoned houses and no improvement. To encourage owner occupied housing should be a value through which you access City regulations. What will improve the quality of housing in our neighborhood? Which ordinances will enable better environments to flourish? By imposing the off-street parking nothing is gained; it is a step backward given the present ownership.

- 1. I think that we should demand that the landlord keep up his property by providing adequate well maintained green space and an hospitable exterior that has a landscape plan suitable for multiple apartments. Children have little or no space to play. In the 20 years I have been here there has been nothing done to improve the back yard at 359 Maria...not a single blade of grass planted, not a single flower. This is a perfect example of absenteeism and lack of oversight.
- 2. Providing off-street parking will perpetuate the "Inner City" character of this house by its industrial impact.
- 3. Given that the owner will probably not have a hard surface parking, there is a significant issue of contamination of the soil. Class 5 simply perpetuates the slum like conditions.

- 4. When there is already more than adequate street parking, I ask, what is the benefit to the neighborhood of pursuing the 4 unit rule for off street parking?
- 5. Why create another attractive nuisance for drug dealing which is rife in this neighborhood, and provide one more secluded place to deal.

I have spoken frequently over the years with the various owners. The building, however, is perceived simply as a source of income, not a place where people want to live, but have to given their economic situation.
