- SPLC 163.03, 163.01 (2), (3) Currently license (tabs) all vehicles on the property and 2. return the vehicles to an operative mechanical condition or remove vehicles from the property.

3. SPLC 34.08 (7) - All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-8989.
