SYNOPSIS:	The Fire Department was called to a report of a trash fire behind a dwelling. Enroute, this call was upgraded to a full assignment of fire companies due to heavy fire extending into the structure. Fire suppression personnel arrived and quickly extinguished the fire. The home owner was alerted to the fire by the reporting 9-1-1 caller and exited the structure safely. The 9-1-1 caller stated he observed a liquid pool fire with blue flames under the rear exterior stairs of the house. The home owner states there have been some problems between her grandson and other boys in the neighborhood. Evidence was collected for testing. The cause of the fire is undetermined pending further investigation and lab results.
