- SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a 2. carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.

### DEDICATION OF RIGHT OF WAY

WHEREAS, the undersigned, HAROLD J. KOHLER and EMMA OPHEIM KOHLER, husband and wife, are the owners in fee simple, as joint tenants, of

Lot Eight (8), Block Twenty-five (25), Warren and Rice's Addition to St. Paul,

on which lot two homes have been built, one of said homes being on the West half  $(W,\frac{1}{2})$  of said lot and the other being on the East half  $(E,\frac{1}{2})$  of said lot, and
