Dear Property Representative:

Your building was inspected on October 24, 2013 for the renewal of your Fire Certificate of Occupancy. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected prior to the re-inspection date. A re-inspection will be made on December 5, 2013 at 1:30 PM.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

DEFICIENCY LIST

- 1. 2ND FLOOR CLOSETS NFPA 13 (2002) 4.1 Provide sprinkler coverage in the missing room or area.
 - -Contact a licensed sprinkler contractor to provide coverage. This work will require a permit. Locations: Hall closets and wine closet.
- 2. 3RD FLOOR HALL MSFC 1028.3 Remove the materials that cause an exit obstruction. Maintain a clear and unobstructed exit way.
 - -Remove table from stairway. Provide another means of barricade for roof access.
- 3. COOLER HANDLE SPLC 34.12 (2), SPLC 34.36 (1) Repair and maintain all required and supplied equipment in an operative and safe condition to properly and safely perform their intended function in accordance with the provisions of the applicable code.

- 4. ELECTRICAL ROOM MSFC 605.3.1 Doors into electrical control panel rooms shall be marked with a plainly visible and legible sign stating ELECTRICAL ROOM or similar wording.
- 5. ELECTRICAL ROOM MSFC 901.6 Provide required annual maintenance of the fire extinguishers by a qualified person and tag the fire extinguishers with the date of service.
- 6. ELEVATOR ROOM MSFC 901.6 Provide required annual maintenance of the fire extinguishers by a qualified person and tag the fire extinguishers with the date of service.
- 7. EMERGENCY LIGHTING MSFC 1010.5, SPLC 34.14 (2) d, SPLC 34.34 (5) b Provide and maintain illumination in all portions of the exit system. -Replace burnt out bulbs and or batteries.
- 8. FRONT DOOR MSFC 1010.1, 1003.3.1.8 Post a sign stating 'THIS DOOR MUST REMAIN UNLOCKED WHEN BUILDING IS OCCUPIED' at main exits with interior key locks. The minimum height of the letter must be 1 inch high with a contrasting background.

 -Provide a sign on the inside of the door facing inward.
- 9. HOOD CLEANING MSFC 904.11.6.3 Contact a qualified hood and duct cleaning service company to clean and service grease duct vent for commercial cooking equipment. Provide documentation as proof of compliance. Maintain venting system in a clean and sanitary condition.
- 10. HOOD SUPPRESSION MSFC 904.11.6.4 Provide required six month service of the hood and duct fire suppression system. Provide documentation from qualified contractor. -*Provide report*.
- 11. KEYBOX MSFC 506.1 Install a keybox.
 -Website for keybox. www.knoxbox.com and look for 1650 Residential.
- 12. LIQUOR ROOM SPLC 34.10 (7), 34.34 (6) Repair and maintain the ceiling in an approved manner.

 -Replace missing ceiling tile.
- 13. MECHANICAL ROOM SPLC 34.10 (7), 34.34 (6) Repair and maintain the ceiling in an approved manner.

 -Replace missing ceiling tiles.
- 14. SPRINKLER TEST MSFC 901.6 Provide required annual inspection and testing of the fire sprinkler system by a licensed fire sprinkler contractor and provide written documentation to this office as proof of compliance. Tags must be maintained on the riser showing the latest date of inspection and testing.

You have the right to appeal these orders to the Legislative Hearing Officer.
