Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **July 31, 2012** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

- 1. Remove debris, shingles, wood, buckets, etc. from the property.
- 2. Trim back overgrown plants impeding access to the front steps and walkway in the front yard.
- 3. Paint unpainted fascia, window frames, trim, etc. on the house.
- 4. Replace rotting decking and rotting handrails on the front entryway of the house.
- 5. Complete work of the eaves of the garage.
- 6. Finish painting the siding, trim and eaves on the garage.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises for **Items #1-2** on or after **August 06**, **2012**, by which date the violations noted must be corrected. The Enforcement Officer will reinspect these premises for **Items #3-6** on or after **August 31**, **2012**, by which date the violations noted must be corrected **Failure to correct these deficiencies may result in the issuance of criminal charges²** and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk's Office at 651-266-8688. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
