We are writing an appeal regarding File #CRT1404, assessment #148203. We are the homeowners. We received the public hearing notice, dated 11/26/13. I have spoken to Mai Vang who encouraged me to write an appeal to be read at the hearing, as I live out of state (Iowa). The purpose of the Hearing Notice is stated as: consider approval for Certificate of Occupancy Fee billed during the time period of August 5 to September 13 2013.

My spouse and I moved out of state in July of 2011. At this time we entered into a contract with Minnesota Home Rental, owner Eric Anderson, to manage our property. We continued this relationship through September 30, 2013. At this time we determined to pursue a Deed In Lieu (DIL) of foreclosure with our mortgage servicer, Quicken Loans, and they received our agreement to pursue a DIL on 9/27/13. The initial notifications of the inspection fees and certificate of occupancy were sent to Minnesota Home Rental and were subsequently unpaid. These fees went unpaid unbeknownst to us, the owners, until this Public Hearing Notice, dated 11/26/13 was received.

After receipt of the Public Hearing Notice, I contacted Mai Vang, as previously mentioned, and the fire inspector by phone to inform them of the current status of our home. While the DIL process is taking much longer than expected, we are hopeful that final paperwork confirming a transfer of our home's deed will be in place very soon. I am in weekly contact with Quicken Loans regarding this process.

I recognize the need to have a certificate of occupancy and the fees associated with the certificate. I would like to pay those, in the amount of \$170.00. I am asking your honor to forgo the additional fees in the amount of \$155.00, as we were not aware that Minnesota Home Rental did not fulfill their obligation to pay this fee.

Thank-you for the opportunity to write this appeal and have it read on our behalf at this hearing. We look forward to your decision.
