As owner or person(s) responsible for: 2340 BUFORD AVE you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

Boulevard plantings.

Per Chapter 105.04 of the St Paul Legislative code:

- 1) Plantings must be maintained in such a way that there is no overhang or encroachment onto the sidewalk, curb or street area.
- 2) Plantings may not exceed thirty-six (36) inches in height.
- 3) Plantings within thirty (30) feet of any intersection may not exceed eighteen (18) inches.
- 4) Plantings within five (5) feet of any alley or driveway may not exceed eighteen (18) inches.
- 5) Plantings within ten (10) feet of street sections that do not have parking lanes may not exceed eighteen (18) inches.
- 6) Plantings within ten (10) feet of street sections where rush hour or 24 hour no parking restrictions apply may not exceed eighteen (18) inches.

Cut/trim or remove and properly dispose of any plantings in violation of chapter 105.04

Obstruction of Public right of Way (ROW) nuisance. Bushes, plantings, vegetation, trees etc.

Per Chapter section 231.01 of the St Paul Legislative code:

Obstruction of the right of maintains a nuisance.

There are Bushes, plantings, vegetation, trees etc. growing over and obstructing the alley, public sidewalk and or curb/ street. Cut/trim or remove and properly dispose of any Bushes, plantings, vegetation, trees etc. that are obstructing the alley, public sidewalk and or curb/street.

FRONT YARD PLANTINGS OBSTRUCTING PUBLIC SIDEWALK.

If you do not correct the nuisance or file an appeal before October 04, 2013, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.

You must maintain the premises in a clean condition and provide proper and adequate refuse storage at all times
