Dear Madame:

We are writing to notify you that we have completed our review of your report of damage to your property at 979 University West on or about 7/9/12. You allege that vibration from Walsh Construction Company (Walsh) work caused exterior damage to sidewalks and extensive interior cracking of plaster walls.

Pre-construction photos and video show the exterior damage existed before our work started. There are old exterior cracks in the building that radiate through to the interior plaster walls. Our investigation of the building, including the basement, revealed old sagging floors. When a floor sags there is so much stress and movement to the building that old plaster walls crack severely. Our investigator observed and photographed wall cracks that had spider webs and/or showed evidence of previous patching. Thus they could not have been new cracks.


