## **NOTICE OF PUBLIC HEARING**

Sound Level Variance Xcel Energy Pipeline Replacement Project

St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source may be affected by this variance request.

Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## **Description of Variance:**

Location: West and East sides of Interstate 35 E on Eleanor Avenue

**Noise Source:** Xcel Energy, represented by Conrad A Miller, Senior Engineer has requested a sound level variance for construction and work using various pieces of equipment, including directional drilling equipment on the West and East sides of Interstate 35E to install a new 20 inch steel pipeline under Interstate 35E as part of a pipeline replacement project. Noise is expected to be from operation of drilling equipment and support vehicles. The Department of Safety and Inspections (DSI) will be recommending the following conditions: 1.The variance will be for construction work on the West and East sides of Interstate 35E along Eleanor Avenue beginning Tuesday April 15, 2014 through Saturday, June 14, 2014. 2. Work periods will be restricted to Monday through Saturday, beginning at 7:00 a.m. and ending at 10:00 p.m. No work will occur on Sundays. 3. The Contractors working on the project will use best practicable methods for controlling noise.
