0100 hours, WHITFIELD was inside on the porch and knocked on the front door of the house. HARSTON stated WHITFIELD asked if she could spend the evening. HARSTON said he told WHITFIELD "no" and then WHITFIELD got upset and he shut the door on her. HARSTON reported he "taunted" WHITFIELD through the door and then he saw her punch the porch window. HARSTON told me WHITFIELD then opened the front door to the house, came inside, and started punching him. HARSTON stated WHITFIELD bit him and was punching him leaving her blood on his clothing and inside the house on the floor. I saw blood on his shirt. HARSTON said WHITFIELD's sisters picked her up and drove her to Regions Hospital.

HARSTON reported this is the fifth window that WHITFIELD had broken. HARSTON told me he did not want anything done about the assault, he only wanted a report done about the window because he has to pay for each one.

I gave HARSTON my business card with the case number on it and a Crime Victim Information Card.

I drove to Regions Hospital and spoke with WHITFIELD who told me her sisters had dropped her off at HARSTON's house after leaving the bar. WHITFIELD stated that HARSTON was gambling with friends at the house and she saw money on the floor so she inquired about the money HARSTON owed her. WHITFIELD reported she became upset when HARSTON told her to leave so she began physically fighting with him. WHITFIELD said during the fighting, HARSTON pushed her into the porch window and it broke. WHITFIELD told me she must have passed out and only remembered her sisters picking her up off the ground and driving her to the hospital.

WHITFIELD told me she was "responsible" for starting the fight with HARSTON, but did not intentionally break the porch window.

I saw a laceration on the inside of WHITFIELD's right arm. WHITFIELD stated she was not injured anywhere other than her arm.

On 05/02/2012, I, Sgt. N. Peterson, was assigned to the Family Violence Unit. At approximately 1025 hours, I called KEAVIN KEANDRE HARSTON. HARSTON told me he was in a romantic relationship with CHAKIRA CHANTEL WHITFIELD for about a year. They ended their relationship about three months. He said she still comes over on occasion and she was last over about a week ago.

On 04/30/2012, WHITFIELD had just left a club and had been drinking. She was with her sisters. WHITFIELD went over to HARSTON's house and he would not let her in. She was standing outside the porch. She was upset because WHITFIELD had locked her out. She began pounding on the window and broke the window. Her sisters loaded her into the car. They were talking about taking her to Regions Hospital.

I asked HARSTON if WHITFIELD assaulted him. He said she did not. He told me she was outside the porch the entire time and she did not get close enough to hit him.

According to HARSTON, WHITFIELD has broken out several of his porch windows in prior incidents. He has not reported those.

WHITFIELD told me he did not know HARSTON's sisters names, nor their contact information.

WHITFIELD said he has not gotten an estimate on the broken window; however, he plans to get one. I gave WHITFIELD my contact phone number and told him to call me when he got an estimate.

On 2-24-12 at 2236 hours, SQD 339 Welters, was sent to 1035 Magnolia Ave E on the report of a female who called 911 asking for police help and hung up. Several call backs by Dispatch were unsuccessful in contacting the caller.

When I arrived on scene I was met at the front door by ROSEMARIE HARSTON (DOB/3-10-63, 612-214-0348). I informed HARSTON that there was a 911 call made requesting police at the address, and I asked HARSTON if I could come in and check to make sure everyone inside was safe. HARSTON told me that I could come inside and check the house. HARSTON also stated that an ex-girlfriend of her son was probably the one who called the police, but that there was no longer any problem. I said that if it was okay with her I would like to take a quick walk though of the house to make sure there was not anyone in need of police help, HARSTON stated that would be fine.

I entered the house and also located inside were JOE CARTER (DOB/7-6-61, 651-208-1233) and AKIA ANTONIO PITT (DOB/10-29-93).

I started off and checked the main level which included the kitchen, living room, bathroom and two bedrooms. I then went into the basement and checked there. The basement consisted of a large open area with the area under the stairs walled off. The walled off portion under the stairs had a door in it that was ajar and I could see a light emitting from the area. I stepped through the open door and in plain view there were 11 marijuana plants underneath florescent lighting. The plants were approximately 12 inches tall, all planted in individual pots.

I went back upstairs and at that time PITT had left the house. HARSTON told me that she lived across the street with PITT who was her son, and CARTER told me that he only visited the house on occasion. HARSTON told me that her other son and two room mates lived in the house. HARSTON said that the occupants of the house were:

KEAVIN KEANDRE HARSTON (DOB/4-20-87) MARCUS ALLEN BOLTON (DOB/12-18-85) RONALD EARL DAVIS (DOB/8-19-51)

A check of RMS showed all three of the above listed as arrestees, from a single incident on October 19, 2011, with the address of 1035 Magnolia.

In addition to the marijuana plants in the basement there were two digital scales recovered in the living room of the house. One was sitting in plain view on top of a table/cabinet and another was sitting in plain view inside a cabinet that had the doors open. Inside the open cabinet I could see a orange prescription drug bottle. I picked up the bottle and it had the name ELIZABETH EZELL on it. The bottle contained 31 pills of Methocarbam 500mg, a muscle relaxant.

SQD 362 Slaghter arrived on scene and took photos of the scene (see supplemental report).
