First, thank you for your continued help with this matter. I really appreciate your willingness to work with me.

Enclosed please find a copy of the accepted estimate for the repair work at the above property. One revision to the attached is that it is my understanding that the \$14,000 line item for the interior painting has not been accepted. I will keep you apprised of the status of other bids for that work.

Also enclosed is a rough draft of the required affidavit evidencing my client's plan and ability to pay the amounts reflected in the estimate. Please advise as to whether this language meets with your approval or what additional language you would like to see in the affidavit

The code compliance inspection was ordered and paid for yesterday. Regarding the bond, until we spoke on Monday, my client was planning on a \$5,000 bond. That amount has been approved, and I expect to receive a check in that amount soon. Monday you advised that a bond was now required in the amount of \$10,000. My client is in the process of obtaining approval for the additional \$5,000. My understanding is that the increase in the bond has not altered my client's plan, but there may be a delay in obtaining the additional \$5,000.
