## **NOTICE OF PUBLIC HEARING**

Sound Level Variance March of Dimes March for Babies Event Como Lake 2014

TO: District 10 Como Community Council

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request.

Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## **Description of Variance:**

Location: Como Lake near the intersection of Como Lake Drive and Lakeview Avenue

Noise Source: The March of Dimes March for Babies Event, represented by Abby Walker, MFB Event Coordinator, has requested a sound level variance in order to allow broadcasting of music from the Jack FM Radio Van. It will be located near the intersection of Como Lake Drive and Lakeview Avenue from 10:00 a.m. until 12:30 p.m. on Saturday, April 26, 2014. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The variance shall be for the hours of 10:00 a.m. to 12:30 p.m. on Saturday, April 26, 2014. 2. All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:30 p.m. on the event date.
