Mr. Nece gave me permission to file the appeal even though it is past the 10 day period given in the letter, so I am grateful for this opportunity to do so.

The upstairs bedroom is quite close to meeting the guideline requirement for ceiling height and I understand that it may be possible to obtain a variance in such cases. I am requesting such an exception or variance in this case as it would be quite a challenge to change the ceiling height on such a small area in order to continue using the upstairs for a bedroom.

The square footage of this area is 140 square feet which is 63% of the floor area.
- 3. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.

- 3. Interior Bedrooms MN State Statute 299F.50 Immediately provide and maintain an approved Carbon Monoxide Alarm in a location within ten (10) feet of each sleeping area. Installation shall be in accordance with manufacturers instructions.
- 4. Interior Upstairs bedroom SPLC 34.13 (1) Provide and maintain all habitable areas with a ceiling height of 7 feet over 1/2 the floor area.-The dimensions of the upstairs bedroom is 20 feet length x 11 feet width. Total square footage equals 220 square feet. The height of the room is 6 feet 10 inches. The width of the bedroom at this height is 7 feet. The square footage of this area is 140 square feet which is 63% of the floor area.
- 5. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- 6. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.
