The Payne Phalen District Five Planning Council held its Community Planning and Economic Development Committee (CPED) monthly meeting on March 4, 2014. The matter of pending License Applications for 956 Payne Avenue Schwietz's Saloon & Eatery was added to the Committee Agenda.

Mr. Ed Bertges, business owner, gave a brief presentation on the license application process, his business plan and the due diligence efforts made to secure the required 60% of signatures. He secured 52% of the signatures. The Committee determined that the efforts made were reasonable and sufficient. In this area of District Five, it has often been difficult for business owners to achieve the full 60% of signatures from area property owners. This is due to the difficulty in reaching the owners of vacant properties. The area is very diverse in terms of first languages. Some business owners find there are language barriers when seeking to explain the petition process.
