## **NOTICE OF PUBLIC HEARING**

Sound Level Variance for an Outdoor Event at Rice Park Ordway Center Flint Hills Children's Festival

## St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request.

Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## **Description of Variance:**

Location: Event will be located outdoors at Rice Park

Noise Source: The Ordway Center For The Performing Arts, represented by Julia Erickson, Associate Production Manager, has requested an exemption from the sound level limitations in Chapter 293.07 in order to allow amplified sound and live music, in Rice Park, between 10:00 a.m. and 5:00 p.m. for six (6) days starting on Tuesday, May 27' 2014 through Sunday, June 1, 2014. The Department of Safety and Inspections (DSI) has recommended the following conditions. 1) The variance will be for the Ordway Center Flint Hills Children's Festival to be held in Rice Park, for the hours 10:00 a.m. and 5:00 p.m. for six (6) days starting on Tuesday, May 27' 2014 through Sunday, June 1, 2014. 2) All electronically powered equipment, PA systems, loudspeakers, musical instruments or similar noise producing devices used in conjunction with the event must not exceed 85 dBA, as measured at 50 feet from any stage or sound source. 3) The applicant will provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers musical instruments or similar noise producing devices must be turned off no later than 5:00 p.m. on each of the event dates.
