On 05-25-2013 at 1712 hours, Squad 195 (Yang) responded to a fight at the intersection of Como and Topping. Call comments stated two males were physically fighting in the middle of the road. One male had a shirt on and the other male was wearing a white t-shirt.

I, Officer Yang, arrived on scene and observed two males standing in the middle of the road behind the rear of 483 Como Ave. Both males were moving around but did not appear to be physically fighting. One male was a light skin black male who was not wearing a shirt. He was later identified as

The other male was heavier set and wearing a black t-shirt (later identified as Lamont Ray BROWN, DOB 11-27-1980, 1068 WESTERN AVE N, ST PAUL MN 55104, C# 651-373-3894). I observed Lamont shoving It appear he was attempting to push him away from the houses. I noticed Lamont holding a dark object in his hand which appeared to be a gun. As soon as my squad pulled to a halt approximately 20 feet in front of them I observed Lamont tossed the object towards a trash bin. I exited my squad car and drew my gun at both of them, ordering them to prone down on the ground.

I immediately handcuff both parties for my safety. Squad 196 (Zauhar/Malmberg) arrived. They were instructed to search and secure the parties. I walked to the trash bin and observed a glock 23 (40 caliber - serial number RTY476) inside the bin. There was a black Kershaw pocket knife next to the gun. The serial number on the gun was ran via channel 5 and it came back cleared.

Lamont was placed in the rear of my squad and transported to the Ramsey County LEC. He was booked for GM possession of a firearm without a permit. It should be noted RMS showed Lamont was charged with felony possession of controlled substance but I was unable to determine if he was convicted of the crime.

We were able to determine the party initially fighting with had fled on foot before police arrived on scene. was not injure and refused medical attention. was released on scene.

Squad 160 (Zink) took photos of the gun. See his supplement report.

The gun was recovered and turned into Forensics Locker #33. The pocket knife carefully folded and turned into Property Room Locker #5.
