Brown initialed the form indicating that he understood his rights. Brown agreed to speak with me about his arrest. I digitally recorded the interview.

| Brown said that he was at him mom's house at 483 Como. His brother Lashon Brown lives upstairs and his |

| stated that Lashon and were fighting. His mother kicked everyone out of the house. Brown said he |
| ownes a Glock 23 G4, 40 handgun that he was keeping at his mom's. Brown said he was keeping his gun and |
| belongings there because his girlfriend kicked him out of his house a couple of weeks ago. I asked Brown if he |
| was wearing a black t-shirt as described in the police report, he said yes. I asked was shirtless. Brown |
| said yes. I asked if Lashon was wearing a white t-shirt, Brown said yes. |

Brown said that he was leaving to go to his house that is just around the corner. Brown asked him mom for his gun. Brown's mom gave him his gun. Brown explained that he was walking down the stairs and asked him mom for the gun case. Brown's mom refused to give it to him. Brown said he wanted the case because he knew that he was not suppose to walk around with an un cased gun. Brown said decided to leave and was walking out the back when he saw the police arrive. Brown said he immediately threw his gun in the trash can that was in the alleyway along with a knife. Brown said he put his hands up and was directed by officers to lie on the ground which he did.

Brown said that he told officers in the back seat of the squad car that he put his gun in the trash can. I asked Brown if he was standing in the alleyway when he was stopped. Brown said he was. I asked Brown if he pointed his gun at anyone or threatened anyone with it. Brown said no. Brown said he was going to walk home when the police arrived, everything happened so fast. I asked Brown if his gun was loaded or had a bullet in the chamber. Brown said he did not know. I asked Brown if he had a permit to carry a concealed weapon. Brown said he did not have a permit but was planning on getting one.

I asked Brown if he bought the gun. Brown said he received a purchase permit from Ramsey County and

bought the gun at Joe's Sporting Goods sometime in 2011.

I asked Brown if he has been arrested for a felony. Brown said he was arrested for crack cocaine in 1999 or 2000 but thought it was expunged from his record. I concluded the interview and downloaded it into the media vault.

I ran a crim history for Brown and found he was convicted of drugs 5th deg on 4-21-2000 and the amended disposition was dismissed on 4-18-2003. I conferred with RCA Jill Gerber about his status as a felon in possession of a firearm. Gerber believed the arrest did not count as a conviction thus not making his status as an ineligible.

I then spoke with City Attorney Maureen Dolen and explained the circumstances of the case. Dolen asked me to fill out a detainer to request a hold be placed on Brown for Poss of a Pistol w/o a Permit. I completed a judicial detainer and brought it to the Watch Commander's office for a judicial review.
