## Sound Level Variance Application Highland Business Association Highland Fest 2014

**Event:** Highland Fest 2014

**Description of Variance:**

**Location:** Event will be located outdoors at 1978 Ford Pkwy

**Noise Source:** The Highland Business Association Highland Fest has applied for a sound level variance in order to provide outdoor music at Hillcrest Park, 1978 Ford Pkwy on Friday, July 18, 2014 from 5:00 pm to 9:30 pm, and a movie until 11:00 pm; Saturday, July 19, 2014 from 10:00 a.m. to 10:30 p.m.; and Sunday, July 20, 2014, from 10:00 a.m. to 7:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 5:00 p.m. to 9:30 p.m. for music, and, until 11:00 p.m. for a movie on Friday, July 18, 2014; from 10:00 a.m. until 10:30 p.m. on Saturday, July 19, 2014; and from 10:00 a.m. until 7:00 p.m. on Sunday, July 20, 2014. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for amplified music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:00 p.m. on Friday, July 18, 2014, no later than 10:30 p.m. on Saturday, July 19, 2014 and no later than 7:00 p.m. on Sunday, July 20, 2014.
