RE:	Streetcar Feasibility Study Outreach Activities

The Saint Paul Streetcar Feasibility Study was a year and a half long study looking at the technical feasibility of bringing streetcars to the streets of Saint Paul, with the intention of making a recommendation for next steps should the City decide to pursue the construction of streetcars. The consulting team from Nelson\Nygaard, HDR and Richardson Richter & Associates were tasked with the technical analysis and reports production, including a strategic communications plan. City staff and the consulting team made numerous presentations to various community groups, professional organizations and business associations. In addition to direct outreach to these groups, the Saint Paul Transportation Committee has acted as the steering committee for this study. This Committee is comprised of representatives from the community who represent various transportation interests, including freight, bicyclists, and the disability community. Three open houses were held at the Rondo Community Outreach Library, the Randolph Fire Station, and the Dayton's Bluff Rec Center. A series of three questions were posed on Open Saint Paul. Letters and emails were also received by staff. And the Planning Commission held a public hearing, where 13 individuals testified. In total, approximately 300 individual pieces of testimony from members of the public were received. A summary of all public input is included in a separate memo.
