Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

#### DEFICIENCY LIST

- 1. Exterior Yard SPLC 45.03 (6) Cut and maintain the grass/weeds less than 8 inches tall.-Cut grass and weeds throughout the property. Remove over grown vegetation on east side of the property.
- 2. North Exterior Handrail SPLC 34.09 (2), 34.32(2) Repair or replace the damaged handrail in an approved manner. This work may require a permit(s). Call DSI at (651) 266-9090.-Repair and secure handrail on north staircase.
- 3. South Exterior Slab SPLC 34.09 (2), 34.32(2) Repair or replace the unsafe stairways, porch, decks or railings in an approved manner. This work may require a permit(s). Call DSI at (651) 266-9090.-Repair deteriorated south facing slab.
- 4. UNIT 3 ELECTRICAL SHUT OFF SPLC 34.23, MSFC 110.1 This occupancy is condemned as unfit for human habitation. This occupancy must not be used until re-inspected and approved by this office.-Restore electrical services to unit immediately or vacate the unit by date listed above.
