To Whom it May Concern:

I am appealing my deficiency list generated after the property re-inspection at 2053 Reaney Avenue on the following grounds:

Line Item #1: This was not a deficiency written up in the initial inspection. Writing up additional items upon the re-inspection is unfair and seems to be a ploy to make more money in re-inspection fees. It should be the responsibility of the inspector to identify all items needing correction upon the first visit to the home.

Line Item #2: We have 2 dehumidifiers running in the basement continuously and have used a shop-vac to remove excess moisture. We have made any and all reasonable efforts to remove dampness from the basement. This is an old house and it has been an unusually heavy rainy and we spring. I do not know what other steps I can take to remedy this problem.

Line Item #3: I made several attempts to get tenants to Ilcense their dogs. At this time, they cannot afford it and are moving from the property (out of state) at the end of July. Rental housing inspections are to make sure there are no life or safety hazards. It should not be the landlord's responsibility to enforce dog licensing requirements.

In addition, given the fact that I worked to the best of my abilities to correct the deficiencies on the original write-up, I do not feel I should be assessed a re-inspection fee for the remaining items I am appealing.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

- 1. Upstairs MN Stat. 299F.362 Immediately provide and maintain a smoke detector located outside each sleeping area.-You cannot substitute a battery operated smoke detector for a hardwired smoke detector that is present in the upstairs hallway
- 2. SPLC 34.10 (1) Abate and maintain the basement reasonably free from dampness and free of mold and mildew.
- 3. SPLC 200.02 (a) No person shall own, harbor, keep or maintain in the City and dog over three months of age without a license. Provide written documentation of current license to the Fire Inspector. To obtain a dog license, contact DSI at 651-266-8989
