The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:00 a.m. to 10:00 a.m. at Mississippi River Blvd, South of Ford Pkwy near Lock and Dam No. 1 Site for the Event on Saturday, August 30, 2014. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 a.m. at the Mississippi River Blvd, South of Ford Pkwy near Lock and Dam No. 1 Site on the date of the event.
