At Upper Landing Park and Old Chestnut Road and Shepard Road, the variance is requested for 8:30 a.m. to 12:00 p.m. For Shepard Road and Washington Street, the variance for Shepard Road and Washington Street is requested for 7:00 to 11:00 a.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:30 a.m. to 12:00 p.m. at 1) Upper Landing Park and Old Chestnut Road and Shepard Road for the Event on Saturday, August 30, 2014. For location 2) Shepard Road and Washington Street, the variance shall be limited during the hours of 7:00 a.m. to 8:00 a.m., and then shall be raised during the hours of 8:00 a.m. and 11:00 a.m. at Shepard Road and Washington Street on August 30, 2014. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for music and/or announcements, except for the hours of 7:00 a.m. to 8:00 a.m. at the 2) Shepard Road and Washington Street location, when all electronically powered equipment used in conjunction with the event shall not exceed 75 dBA as measured 50 feet from any sound source 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. at the Upper Landing Park and Old Chestnut Road and Shepard Road site, and no later than 11:00 a.m. at the Shepard Road and Washington Street location on the date of the event.
