Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment,

etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.

Appeals: You may appeal this order and obtain a hearing before the City Council by completing an appeal application with the City Clerk before the appeal deadline noted above or seven (7) days after the date mailed, whichever comes first. You must submit a copy of this Correction Order with your appeal application.

*WARNING Code inspection and enforcement trips cost the taxpayers money.
