Dear Mr. Anderson,

It was good to hear from you and discussing the installation of the new meter and the reinstatement of your water service. A St. Paul Regional Water Services Meter Technician will inspect the meter setting, install a new R900I radio transmitting water meter, and turn the water back on, assuming the plumbing at the meter setting is up to code, as we discussed, there cannot be any galvanized before the meter, there must be 2 working valves, which you are in the process of replacing, if there are any issues the technician sees they will inform you of the deficiencies and leave the water off until the repairs are made, if the issues are minor and can be corrected while the technician is at the property, within a reasonable time, they will wait for you to make the repairs. The only issue I can foresee is if you have any leaks on the ball valves that you were not able to check since the water is off, the tech will wait for you to tighten the joints.

As we discussed we will be able to install the new meter and reinstate the water service in the next 2 weeks, the technicians will be able to keep an appointment on any business day in the next 2 weeks, Meter Operation hours are: Monday - Friday, 8AM-12PM or 1PM=3PM. Please let me know what day and time is convenient for you and I will put you on the schedule, a normal meter installation should take less than ½ hour of your time.
