NOTICE OF PUBLIC HEARING

Minnesota Opera Outdoor Live Simulcast - Rice Park

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Description of Variance:

Location: Rice Park

Noise Source: Minnesota Opera has requested a sound level variance in order to present a live simulcast of a September 20, 2014 Minnesota Opera and Ordway Collaboration Performance at the Ordway, with the simulcast at Rice Park. The variance is requested for the noise source of operation with the show performance from 8:00 p.m. to 11:00 p.m.

The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the Minnesota Opera live simulcast Event at Rice Park on September 20, 2014. Minnesota Opera is working in collaboration with the Ordway on the live simulcast. 2) Noise source of operation for the show performance is 8:00 p.m. to 11:00 p.m. on Saturday, September 20, 2014. 3) All electronically powered equipment, PA system, loudspeaker or any similar device used in conjunction with the event, will not exceed 85 dBA, as measured 50 feet from any stage or sound source used for music and/or announcements between the hours of 8:00 p.m. and 11:00 p.m. 4). The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 5). All electronically powered equipment, PA systems, loudspeakers or similar devices will be turned off by 11:00 p.m. on September 20, 2014.
