An inspection was made of your building on September 10, 2014 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately.

A reinspection will be made on or after September 22, 2014.

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

- 1. Exterior Along driveway SPLC 34.08 (3) Provide and maintain suitable ground cover on all exterior areas to control erosion.-Tenant has been driving on the grass and it is now dirt.
- 2. Exterior By garage SPLC 34.08 (7) All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-9090.-Tenant was parking a car in the grass.
- 3. Exterior In grass next to garage SPLC 163.03, 163.01 (2), (3) Currently license (tabs) all vehicles on the property and return the vehicles to an operative mechanical condition or remove vehicles from the property.-There was a car without plates on it in the yard.
- 4. Lac of basic facilities Gas SPLC 34.23, MSFC 110.1 This occupancy is condemned as unfit for human habitation. This occupancy must not be used until re-inspected and approved by this office.
