Noise Source: Team Ortho Foundation, Monster Dash 10 Mile Finish Area has applied for a sound level variance in order to provide a Mobile DJ with use of Speakers at the Monster Dash 10 Mile Finish Area, Shepard Road, between Homer and Elway for their Event on Saturday, October 25, 2014 from 9:00 a.m. to 11:30 a.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 9:00 a.m. to 11:30 a.m. for Shepard Road, between Homer and Elway, for a Mobile DJ with use of Speakers on Saturday, October 25, 2014. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for amplified music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:30 a.m. for Shepard Road, between Homer and Elway on Saturday, October 25, 2014.
