CPED Agenda Review and Approval

Amend agenda to add the Railroad Island Task Force Rivoli Bluff item as the third item, after the 845 Payne Ave issue. Motion by Regina Rippel to approve Agenda as amended. Second by Keith Schmalzbauer. Motion was approved.

Approval of Minutes from September 2014

Motion by James Lockwood to approve Draft CPED Minutes from September 9, 2014. Second by Schmalzbauer. Motion was approved.

1124 Payne Ave — Cook St Paul LLC, dba Cook St Paul - Application for Wine On Sale, and Malt On Sale (Strong), Eddie Wu, owner

Asking for a waiver for the Beer and Wine license to be issued prior to the expiration period. The current date is November 7th. He wants to have it before that, so he can coordinate it with a celebration of fellow veterans. He would have put in the request earlier, but it was a matter of having the cash for the application. Hours of operation remain the same: Monday – Friday 6:30 AM to 2:00 PM, Saturday and Sunday 7:00 AM to 3:00 PM.

845-851 Payne Ave - Interim Use Permit These are HRA (city) owned lots proposed for a temporary parking lot for businesses on Payne Ave.

This parking lot will be used until the Wells Street parking lot is available, which would be sometime in 2015. Questions were raised concerning paying for temporary lots, as other businesses have been told they would be responsible for any lot improvements of temporary lots, while it appears that HRA is paying for this temporary lot.

Motion by David Syers to support the application. Second by Darlene Adams. Motion passed unanimously.

Village on Rivoli Housing

This proposal is based on a previous presentation to the Committee. There is a slight change in the plat map.

Motion by Copeland to support the proposal, contingent on approval by the RRITF. Second by Marque Garczynski. Motion passed unanimously.
