Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday**, **December 17**, **2014 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the resolution and supporting documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that the liquor liability insurance you submitted to the Department of Safety and Inspections showing coverage from October 31, 2014 through October 31, 2015 did not show required coverage from December 16, 2013 through October 31, 2014. Because of this lapse in coverage, you had been operating a liquor serving establishment without any liquor liability insurance for 10 ½ months.

As a result of this egregiousness conduct, per Saint Paul Legislative Code § 409.26 (b) (12), the licensing office will recommend revocation of all licenses.
