1. The licensee will provide and maintain working video surveillance cameras and equipment to record activity on the premises and in accordance with SPPD recommendations. Tapes and recordings must be maintained for a minimum of thirty (30) days and there shall be an employee on staff at all times during business hours with the ability to make the recordings immediately available to the SPPD and/or the Department of Safety and Inspections (DSI) upon request and/or to DSI within two(2)days of request.
2. Exterior lighting must be maintained and adequate to support the camera/security equipment.
3. Staff will monitor the entrance and exits to ensure no liquor leaves the establishment and that patrons are not loitering in the parking lot.
4. No patrons will be allowed entrance after 1:30 A.M. and last call will be given at 1:30 A.M.
5. License holder and/or staff will immediately notify police of any individuals engaging in unlawful behavior.
6. Litter on and around the premises is to be picked up daily.
7. Security personnel shall be assigned to the entrance starting at 9PM on all nights that entertainment is provided and remain until all patrons have left the licensed premises, which includes the parking lots. Security personnel shall "wand"(using a metal detector) each patron and check all handbags and packages carried by patrons. Security shall verify the age of patrons by checking state or federally issued identification cards (no picture I.D. no entrance). Customers re-entering the establishment shall be subject to the same security measures as customers entering the establishment for the first time.
