Your building was inspected on November 5, 2014 for the renewal of your Fire Certificate of Occupancy. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected prior to the re-inspection date. A re-inspection will be made on December 5, 2014 at 1:00P.M.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

DEFICIENCY LIST



All bedrooms - MSFC 1026.1 - Provide and maintain an approved escape window from each sleeping room or area, or discontinue use of area as a sleeping room. This work WILL require permit(s). Call DSI at (651) 266-8989.-Per the owner windows measured . Owner was told could not enforce the egress window code. These are awning windows. 40 inches in width. 25inches in height. The openable height is 14 inches. Openable width is 39inches. The window sill is 56inches and does already have egress steps. The bedroom is 10' by 13.5 feet

- 2. Remove all gas cans from louse MN Stat 299F.18 Immediately remove and discontinue excessive accumulation of combustible materials.
- 3. Various locations MSFC 605.5 Discontinue use of extension cords used in lieu of permanent wiring, usage exceeds amperage.
- 4. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- 5. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.
- 6. SPLC 34.08 (7) All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-9090.
- 7. MSMC 504.6 Provide, repair or replace the dryer exhaust duct. Exhaust ducts for domestic clothes dryers shall be constructed of metal and shall have a smooth interior finish. The exhaust duct shall be a minimum nominal size of four inches (102 mm) in diameter and installed in accordance with the mechanical code. This work will require a permit(s). Call DSI at (651) 266-8989.-The dryer duct does not have code compliant material. The dryer duct at present is split open.
- 8. MFGC 409.5 Provide an approved gas shut off valve within 6 feet of the appliance in accordance with the mechanical code. This work may require a permit(s). Call DSI at (651) 266-8989.
