Thank you for your time today to discuss the possible extension of the permit approval due on December 3, 2014 per your letter of November 21, 2014.

### Todd Sutter, City of St. Paul Building Inspector (651-266-9024) stated:

He was not included in the initial inspection of this property site project and would like to schedule a meeting on site to inspect the completed restoration that has been done with a HPC representative. He also needs the HPC approval letter that is usually issued at the time the Building Permit is released by the City.

He is booked solid until the second week of December 12/8/14 – 12/12/14. Please advise when the HPC representative is available to meet on site to review the project so that when he signs off on the permit, it is approved by all.

As you indicated that you will be in contact with Amy Spong today at a 9 AM hearing, please advise if she can provide some dates and times in the second week of December to coordinate the inspection ----if you can extend the deadline of 12/3/14 per your letter to the second week of December.
