

**SUMMARY OF ENGINEERING RECOMMENDATION**  
**N. Chatsworth St. New Sidewalk Construction**

**Ward 5**

**PROJECT:**

This project is to complete the city sidewalk on the east side of **N. Chatsworth Street between Como Aveune and Como Boulevard West**. The new sidewalk is approximately 430' long and will be constructed in front of one property. This sidewalk construction is to be done as part of one of the 2015 RSVP Project.

**EXISTING CONDITIONS:**

This is park property and there is no sidewalk here making this part of N. Chatsworth Street sidewalks incomplete.

**INITIATING ACTION:**

This order was initiated by complaints of the incomplete sidewalk infrastructure in this neighborhood.

**ALTERNATES:**

Do nothing and this area will stay an incomplete walk where pedestrians will need to use the street.

**POSITIVE BENEFITS:**

The people who live in the area will have greater walking access around the park. This improvement will positively affect many.

**ADVERSE EFFECTS**

Normal problems associated with construction such as noise, dust, and general disruption to the neighborhood. There are direct assessments to the abutting properties and some of them may contest the project.

**EFFECTS ON TREES:**

There may be a need to remove some trees and bushes for the new walk but the walk may be able to meander around trees to lessen the impact.

The project to be done in 2015.
