As owner or person(s) responsible for: 908 JEFFERSON AVE you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

X	Remove all improperly stored or accumulated refuse including: garbage, rubbish, discarded furniture, appliances, vehicle parts, scrap wood and metal, recycling materials, household items building materials or rubble, tires, brush, etc., from yard areas. Including and especially, bu not limited to: yard if full of metal tanks, pipe, AC units, radiators, washers. dryers, microwaves, refrigerators, bicycles, chain, lawn-mowers, plus large amount of other of
	microwaves, refrigerators, bicycles, chain, lawn-mowers, plus large amount of other of other refuse and scrap material. (Apparent scrapping operation.)

	IMMEDIATELY secure all buildings which are open to unauthorized entry, including:
X	Other: SCRAPPING/RECYCLING: Scrapping and/or recycling processing is <u>not</u> <u>permitted</u> in a residential zoning district per section 66.221 of the St Paul Legislative Code. A home occupation is permitted in a residential district provided it meets the requirements in Section 65.141 of the St Paul legislative code. This section of the code requires and states there shall be no exterior storage of equipment, supplies or commercial vehicles associated with the home occupation. Additionally, it is required that the dwelling unit be the principal residence of one of the persons conducting the home occupation. <u>IMMEDIATELY CEASE SCRAPPING OPERATIONS</u> .

If you do not correct the nuisance or file an appeal before August 14, 2014, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.

You must submit a copy of this Correction Order with your appeal application.

*WARNING Code inspection and enforcement trips cost the taxpayers money.
