CORRECTION NOTICE

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections, Division of Code Enforcement has inspected the above referenced property on **November 26, 2013** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹:

1. Replace dilapidated roof shingles and remove tarp that is around chimney. Roof repair will require a permit.

- 2. Peeling paint on house trim. Scrape and paint.
- 3. Replace all rotted/dilapidated wood fascia boards.
- 4. Repair, replace or remove all detached and/or inoperable gutters.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after July 01, 2014, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**² and/or a civil lawsuit, and possible abatement/assessment by the City. If you're a Senior and need help complying, call 1-800-333-2433. If you're a person with a disability, call the Disability Linkage Line for assistance at 1-866-333-2466. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989. You may file an appeal to this notice by contacting the City Clerk's Office at 651-266-8688. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
