Sound Level Variance Application 2015 Become Co/Red Bull Frozen City (SLV #1) Locations 2,3 and 10

Event: Become Co/Red Bull Frozen City 2015 (SLV#1), Locations 2, 3 and 10

Description of Variance (SLV #1):

Locations: Location 2 on the Wabasha Street Bridge, Location 3 at Harriet Island and Location 10 at the RiverCentre Parking Ramp 2015

Noise Source: Become Co/Red Bull Frozen City Event, represented by Luke Seile, Become Co/Red Bull, Event Producer, has requested a sound level variance in order to use a specialized snowmobile for Sound Level Variance 1 (SLV#1) at Location 2, on the Wabasha Street Bridge on February 25, 2015, 8:00 a.m. to 10:00 a.m.; Location 3, at Harriet Island on February 25-26, 2015, from 8:00 a.m. to 5:00 p.m. and at Location 10, RiverCentre Parking Ramp on March 2, 2015 from 9:00 a.m. until 5:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The SLV #1 Variance shall be for the hours of 8:00 a.m. to 10:00 a.m. on February 25, 2015 for Location 2; from 8:00 a.m. to 5:00 p.m. on February 25-26, 2015 for Location 3; and from 9:00 a.m. to 5:00 p.m. on March 2, 2015 for Location 10. 2. All noise coming from the specialized snowmobile used in conjunction with the event shall not exceed 91 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All specialized snowmobile sound shall be turned off no later than 10:00 a.m. for Location 2 on February 25, 2015; 5:00 p.m. on February 25-26, 2015 for Location 3; and 5:00 p.m. on March 2, 2015 for Location 10.
