## **NOTICE OF PUBLIC HEARING**

## Become Co/Red Bull Frozen City Event 2015- Sound Level Variance

TO: CapitolRiver Council District 17

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## Description of Variance (SLV #1):

<u>Locations</u>: Location 2 on the Wabasha Street Bridge, Location 3 at Harriet Island and Location 10 at the RiverCentre Parking Ramp

Noise Source: Become Co/Red Bull Frozen City Event, represented by Luke Seile, Become Co/Red Bull, Event Producer, has requested a sound level variance in order to use a specialized snowmobile for Sound Level Variance 1 (SLV#1) at Location 2, on the Wabasha Street Bridge on February 25, 2015, 8:00 a.m. to 10:00 a.m.; Location 3, at Harriet Island on February 25-26, 2015, from 8:00 a.m. to 5:00 p.m. and at Location 10, RiverCentre Parking Ramp on March 2, 2015 from 9:00 a.m. until 5:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The SLV #! Variance shall be for the hours of 8:00 a.m. to 10:00 a.m. on February 25, 2015 for Location 2; from 8:00 a.m. to 5:00 p.m. on February 25-26, 2015 for Location 3; and from 9:00 a.m. to 5:00 p.m. on March 2, 2015 for Location 10. 2. All noise coming from the specialized snowmobile used in conjunction with the event shall not exceed 91 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All specialized snowmobile sound shall be turned off no later than 10:00 a.m. for Location 2 on February 25, 2015; 5:00 p.m. on February 25-26, 2015 for Location 3; and 5:00 p.m. on March 2, 2015 for Location 10.
