NOTICE OF PUBLIC HEARING

Become Co/Red Bull Frozen City Event - Sound Level Variance

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance (SLV #2):

<u>Locations</u>: Location 9 at the State Capitol Overlook, Robert Street North from 12th Street to University Avenue, March 1, 2015

Noise Source: Become Co/Red Bull Frozen City Event, represented by Luke Seile, Producer, has requested a sound level variance in order to use a specialized snowmobile for Sound Level Variance 2 (SLV#2), Location 9, at the State Capitol Overlook, Robert Street North from 12th Street to University Avenue on Sunday, March 1, 2015, 9:00 a.m. to 5:00 p.m.. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The SLV #2 Variance shall be for the hours of 9:00 a.m. to 5:00 p.m. on March 1, 2015. 2. All noise coming from the specialized snowmobile used in conjunction with the event shall not exceed 91 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All specialized snowmobile sound shall be turned off no later than 5:00 p.m. for Location 9 on March 1, 2015.
