Description of Variance:

<u>Noise Source</u>: Patrick McGovern's has requested a sound level variance to present amplified music in an enclosed tent with use of a sound system for St Patrick's Day Events on Saturday, March 14, 2015 and on Tuesday, March 17, 2015 at 225 7th Street West. The variance is requested for the hours of 3:00 p.m.to 12:00(Midnight) on Saturday, March 14, 2015, and from 3:00 p.m. until 12:00 (Midnight) on Tuesday, March 17, 2015.

The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 3:00 p.m. to 10:30 p.m. for the St Patrick's Day Events on Saturday, March 14, 2015, and from 3:00 p.m. until 10:00 p.m. on Tuesday, March 17, 2015. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured inside the tent at the wall opposite of the sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:30 p.m. on March 14, 2015 and no later than 10:00 p.m. on March 17, 2015.
